Director's Message



Namaskar, I feel privileged to place the annual report of NITTTR Kolkata for the financial year 2023-24 for the kind perusal and consideration of the honourable stakeholders of our Institute. The report contains institutional achievement along with the financial statements cast in formats approved by the Ministry of Education, Government of India. I am also pleased to inform you that NITTTR, Kolkata has been conferred Deemed to be University under Distinct Category by the Ministry of Education, Government of India.

In 2023-24, the Institute conducted 165 short-term training programs on different technical, managerial, and pedagogy

subjects both in contact mode and ICT mode. These programs were attended by 12,014 Trainees engaged in teaching in various polytechnic and engineering degree colleges located across the country. 13,552 no. of participants enrolled in the different courses offered under SWYAM MOOCs.

Further, the Institute has conducted 16 workshops on different emerging topics related to curriculum development and implementation, NBA, and Training Need Analysis for the improvement of Technical Education in which 2555 participants attended from various parts of the country.

We also offer full-time M.Tech courses in Manufacturing Technology, Mechatronics Engineering, Multimedia and Software Systems, and Structural Engineering. This year, 12 students received their M.Tech degrees. The research work conducted by faculty members and students has culminated in the publication of 78 papers in reputed journals and conferences and 3 book chapters. Further, it produced 20 educational video films.

Besides all these events, the Institute celebrated successfully several events namely, the 60th Foundation Day of the Institute, Yuva Diwas, Netaji Jayanti, Observance of birth anniversary of Baba Saheb Ambedkar, World Tobacco Day, World Environment Day, Yoga Day, National Education Policy on Higher Education, Independence Day, Ek Tharik Ek Ghanta, Hindi Diwas, Jana Jatiya Diwas, Swachhata Pakhwada, Rashtriya Ekta Diwas, Vigilance Awareness Week, Constitution Day, National Education Day, Republic Day etc.

I take this opportunity to solicit your active participation and kind support from all the stakeholders of the Institute being empowered with NEP 2020 for rejuvenating and repositioning our institute in both national and international arenas successfully. ABOUT US



National Institute of Technical Teachers' Training & Research (NITTTR), Kolkata was established in 1965 as Technical Teachers' Training Institute (TTTI), Calcutta at the premises of Jnan Chandra Ghosh Polytechnic, Calcutta. This was the first of four such regional Institutes (other three being at Chandigarh, Bhopal and

Chennai) established by then Department of Education, Govt. of India as fully centrally funded autonomous institution. Since 1980, the Institute is located at Salt Lake City.

The primary focus of the Institute is to provide in-service training to the teachers and staff of Degree and Diploma level technical institutions and conduct activities related to the quality improvement of the technical education system of the country. NITTTR, Kolkata has been actively involved in improvement of quality of the technical education system in various states including those in the north-east through innovative academic interventions, providing assistance to policy makers at the national and state levels, in formulation of educational plans, projects and their implementation in the fast-changing scenario. The Institute has also established two extension centres at Guwahati (in 1999) and at Bhubaneswar (in 2000) for reaching out to its clients in North-Eastern states and Odisha respectively. By virtue of working closely over the last few decades, this institute has developed a thorough understanding of the technical educational needs of the states in the eastern region including those in the North-east. In recognition of its contribution towards development of excellence in the technical education system, Government of India, in October 2003, accorded National status to the Institute along with its 3 sister institutes located at Chandigarh, Bhopal & Chennai and renamed them as National Institute of Technical Teachers' Training & Research, Kolkata, Chandigarh, Bhopal and Chennai respectively.

Some of the notable national level projects in which the Institute is associated are Nodal agency to Centrally Sponsored Community Development through Polytechnic Scheme, Designing & conducting AICTE sponsored "Induction Training Programme" for fresh teachers of engineering colleges and polytechnics, facilitating implementation of centrally sponsored Scheme for Integrating Persons with Disabilities (PWD) in the Mainstream of Technical & Vocational Education etc.

The focal activities of the Institute are Short Term Training, Curriculum Development, Learning Resources Development, Research in the field of Technical Education System, Educational Management and Extension Services. Besides regular activities, the Institute has been offering, since 2003, AICTE approved M. Tech. Degree Programme in 'Manufacturing Technology', affiliated to Maulana Abul Kalam Azad University of Technology, West Bengal (earlier known as WBUT). During 2005-2006 two more M. Tech. Programmes namely 'Multimedia & Software Systems' and 'Mechatronics' Engineering were started. The M. Tech. Programme in 'Structural Engineering' has been introduced since 2011-2012. The Institute has highly qualified faculty and excellent infrastructural support in the form of well-equipped laboratories, Integrated Computer Centre (ICC), Library Welding Centre, CAD/CAM centre and other resources. At present this Institution is focusing among others, Technical Teachers' Training through ICT Mode.

DEEMED TO BE UNIVERSITY STATUS UNDER DISTINCT CATEGORY

The Institute has been declared as Deemed to be University under Distinct Category as per the Section 3 of the UGC Act, 1956 by the ICR Division, Department of Higher Education, Ministry of Education, Government of India vide its Notification No. 9-1/2021-U.3(A) dated 22nd February 2024.

OBJECTIVES

The objectives of the Institute include:

- i. act as a centre for offering quality training programmes for teachers as per need of the client system, covering the entire gamut of technical education including polytechnics, engineering colleges, vocational and management education, at national as also at international levels;
- ii. arrange for practical training for technical teachers in industries on a cooperative education plan;
- iii. undertake research for development of innovative methods, processes and practices for improvement of teaching-learning environment in technical and vocational education institutions;
- iv. design, develop and disseminate learning resources like Textbooks, Laboratory Manuals, Video Programmes, Computer Assisted Instructional Multimedia Packages to technical and vocational institutions and other organisations;
- v. collaborate with educational, research or any other relevant institutions in any part of the world having objects wholly or partly similar to those of the NITTTR Kolkata Deemed to be University in such manner as may be conducive to their common objects;
- vi. provide support services to Government of India schemes related to technical and vocational education system;
- vii. provide for higher education / training leading to excellence and innovations in such branches of knowledge as may be deemed fit, primarily at undergraduate, post-graduate, and research degree levels, fully conforming to the concept of a University;
- viii. engage in inter-disciplinary or multi-disciplinary or trans-disciplinary teaching and research in addition to domain-specific specialisation;
- ix. provide for high-quality teaching and research recognised nationally and globally;
- x. recognise, identify and foster the unique capabilities of each learner, by sensitising teachers as well as parents to promote each learner holistic development;
- xi. provide multi-disciplinary and a holistic education / training in the faculties of science, engineering, technology, technical education, management, social sciences, arts, humanities and other disciplines;
- xii. transform into teaching and research-intensive University over a period of time;

- xiii. focus on research and innovation by setting up start-up incubation centres; industry-academic linkages; inter-disciplinary research and strengthening research ecosystem by establishing Research and Development Centre (RDC)
- xiv. design and development of flexible and innovative curriculum, which includes credit-based courses and projects as per demand of the clientele;
- xv. contribute for social transformation through socially responsive training, teaching, learning, research, and fieldwork;
- xvi. adopt the provisions of NEP, 2020;
- xvii. possess such academic and physical infrastructure as may be specified by the Commission or the relevant statutory body, as the case may be;
- xviii. have teacher-student ratio of 1:20 with a minimum combined faculty strength of not less than one hundred and fifty teachers and a minimum combined student strength of three thousand on rolls under the regular classroom mode, of which not less than one fifth being post-graduate or research or as per the norms of the relevant statutory body; and
- xix. shall have an administrative area, library, lecture halls, labs, hostels, health care, common facilities and recreational facilities.

MANAGEMENT

NITTTR, Kolkata is an autonomous organization under Department of Higher, Ministry of Education, Government of India. Responsibility for direction and control of the affairs of the Institute is vested in the Board of Governors. The Board functions through its standing committees — the Finance Committee, the Buildings & Works Committee and other committees. 






State-wise Distribution of Participants







I have audited the annual accounts of the National Institute of Technical Teachers' Training & Research, Kolkata, for the financial year 2023-24, and have issued the Audit Report thereon vide letter dated 06.09.2024. During the course of audit, the following deficiency was noticed, but was not included in the Audit Report. It is brought to your notice, for corrective and remedial action:

'The Institute had received an amount of ₹12.70 crore as revenue grant during the financial year 2023-24 and had booked an amount of ₹26.58 crore as expenditure against the revenue grant. The excess expenditure amounting to ₹13.88 crore were met out from the unspent grant of the previous year, in contravention to the condition stipulated in the grant sanctioning letter (Clause No. 4(h) of the grant sanctioning letter). This needs to be rectified.'

Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of the National Institute of Technical Teachers' Training and Research, Kolkata, for the financial year ended 31 March 2024

We have audited the Balance Sheet of the National Institute of Technical Teachers' Training and Research, Kolkata, as at 31 March 2024, the Income and Expenditure Account and Receipts and Payments Account, for the year ended on that date, under Section 20(1) of the Comptroller and Auditor General's (Duties, Power and Conditions of Service) Act, 1971. The audit has been entrusted for the period upto the financial year 2027-28. These financial statements include the accounts of two Extension Centres of the Institute. These financial statements are the responsibility of the Institute's management. Our responsibility is to express an opinion on these financial statements, based on our audit.

- 2. This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment only, with regard to classification, conformity with the best accounting practices, accounting standards and disclosure norms etc. Audit observations on financial transactions, in regard to compliance with the Law, Rules and Regulations (Propriety and Regularity) and efficiency-cum-performance aspects etc, if any, are reported through Inspection Reports/CAG's Audit Reports separately.
- 3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by the management, as well as evaluating the

overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

- 4. Based on our audit, we report that:
- We have obtained all the information and explanations, which, to the best of our knowledge and belief, were necessary for the purpose of our audit;
- ii. The Balance Sheet and Income and Expenditure Account/Receipts and Payments Account, dealt with in this report, have been drawn up in the format prescribed by the Ministry of Human Resource Development, Government of India, vide order No. 29-4/2012-FD dated 17 April 2015.
- iii. In our opinion, proper books of accounts and other relevant records have been maintained by the National Institute of Technical Teachers' Training and Research (NITTTR), Kolkata, as required under the rules and regulations of the Institute, insofar as it appears from our examination of books.

iv. We further report that:

Comments on Accounts

A Balance Sheet

1.1 Assets

1.1.1 Fixed Assets (Schedule 4): ₹32.03 crore

The above head was overstated by an amount of ₹27.75 lakh, as the Institute had booked payment of advance to CPWD for construction works *viz*. Upgradation, Renovation, Repairing and Painting of Sarvepalli Radhakrishnan Bhavan under 'Capital Works in Progress', instead of booking the same as Advance under the 'Loans, Advances & Deposits' (Schedule 8). This resulted in understatement of the 'Loans, Advances & Deposits' (Schedule 8), by ₹27.75 lakh.

B General Comments

- 2.1 The Institute had wrongly charged less depreciation of ₹0.71 lakh, on electrical works amounting to ₹23.51 lakh, which is added to the 'Hostel Building' (@2%) (included in ₹36.27 lakh), instead of adding the same under the head 'Electrical Installation and Equipment' (@5%) in 'Fixed Assets' (Schedule 4). This needs to be reconciled.
- 2.2 The Institute depicted closing balance amounting to ₹0.75 lakh under the head 'Computer Lab' in 'Designated/ Earmarked/ Endowment Fund' (Schedule 2). However, as per the bank statement (Account No.: 10836429526), the closing balance is 'Nil'. This needs to be reconciled.
- 2.3 The Institute had wrongly booked the interest on grants amounting to ₹2.14 crore as income in 'Income from Investment' (Schedule 11) and booked an amount of ₹1.79 crore as refund of interest on grants to the Ministry in 'Other Expenses' (Schedule 21), instead of routing the same through Schedule 3(c) of the Balance Sheet.
- 2.4 The Institute, despite mention in the previous years' Audit Report, has not taken any rectification measures in the following, in contravention to the format of accounts:
- a) No provisions for retirement benefits, such as gratuity, pension and leave encashment, were made on 'actuarial valuation' basis, in contravention of Accounting Standard-15.
- b) The Institute has not disclosed all bank account balances in Annexure- A to Schedule-7.

C Grants in Aid

The Institute is mainly financed by grants from the Government of India. At the end of the financial year 2022-23, the Institute had an unspent balance of ₹39.17 crore, including NER grants of ₹8.21 crore.

During the financial year 2023-24, it received grants of ₹12.70 crore (Plan General (Recurring) (OH-31): ₹3 crore and Non-plan (Salary) (OH-36): ₹9.70 crore) and earned interest on GIA amounting ₹2.14 crore.

Out of the total amount of ₹54.01 crore (including the unspent balance of the financial year

2022-23 and Interest on GIA), so available, it utilized grants of ₹27.62 crore (Creation of Capital

Assets: ₹1.03 crore (leaving the advance of ₹0.28 crore paid to CPWD), General: ₹9.95 crore,

Salaries: ₹16.47 crore and NER: ₹0.17 crore) and refunded interest of ₹1.79 crore, relating to the

previous year, leaving an unspent balance of ₹24.59 crore, including NER grants of ₹8.12 crore.

Subject to our observations in the preceding paragraphs, we report that the Balance Sheet,

Income and Expenditure Account and Receipts and Payments Account, dealt with in this report,

are in agreement with the books of accounts.

In our opinion, and to the best of our information, and according to the explanations vi.

given to us, the said financial statements, read together with the Accounting Policies and Notes

on Accounts, and subject to the significant matters stated above and other matters mentioned in

Annexure to this Audit Report, give a true and fair view, in conformity with the accounting

principles generally accepted in India:


