ABOUT THE INSTITUTE

National Institute of Technical Teachers' Training & Research (NITTTR), Kolkata was established in 1965 as Technical Teachers' Training Institute (TTTI), Calcutta established by the Department of Education, Government of India, a centrally funded autonomous institution. Recently, NITTTR, Kolkata has been declared as **Deemed to be University under distinct category** by the Ministry of Education, Government of India.

DETAILS OF SCOPE OF WORK OR SERVICE TO BE PERFORMED BY THE SUPPLIER

- 1. The Medicine Supplier will provide medicines to employees, and their dependent family members of NITTTR, Kolkata on credit basis on production of prescription prescribed by Part-time Medical Officer (PTMO), NITTTR, Kolkata or refereed specialist by PTMO.
- 2. The Medicine Supplier will provide all medicines prescribed by the Part-time Medical Officer, NITTTR, Kolkata on the same day as far as possible.
- 3. The Medicine Supplier will provide medicines of latest batch and the expiry date should not be less than six months from the date of supply.
- 4. The Medicine Supplier will generate bill showing name of the medicine, batch no., MRP and net cost of the medicine after allowing discount as agreed.
- 5. The Medicine Supplier will maintain sufficient stock of medicines all times to avoid inconvenience to the employees and their dependent family members.

ELIGIBILITY AND QUALIFCATION CRITERIA TO BE MET BY THE BIDDER:

- 1. Copies of valid drug license held by the bidder as on the date of Bid opening in specified forms [(Form 20 & 21) or (20-B 21-B)] and (21-C, if required) for various categories of medicines issued by the Drug Control Authority of the State under the provisions of Drugs and Cosmetics Act, 1940. The successful Bidders will ensure that their license remain valid till the end of the contract period.
- 2. Copy of Declaration of bidder as per *Annexure-I* has to be signed.
- 3. If the bidder is a Partnership concern, copy of the Partnership Deed duly attested by a notary public and an affidavit to the effect that all the partners admit execution of the partnership and the General Power of Attorney may be furnished. In case of partnership firm, where no authority to refer disputes concerning the business or the partnership has been conferred on any partner, the Tender and all other related documents must be signed by each partner of the firm.
- 4. Scanned copy of GSTIN allotment/ clearance certificate.
- 5. An undertaking stating that no case is pending/black listed against the bidder under the Drugs and Cosmetics Act and Rules made there under as well as under the Drugs Price Control Order issued from time to time.
- 6. Scanned copies of the audited balance sheets along with Chartered Accountant's Certificate for the last three financial years to establish the turnover of the bidder.

- 7. Tender must be unconditional; all documents must be self-attested.

CONTRACTUAL OBLIGATIONS:

- The Medicine Supplier will provide medicines to employees, and their dependent family members of NITTTR, Kolkata on credit basis on production of prescription prescribed by Part-time Medical Officer, NITTTR, Kolkata and the same will be reimbursed by NITTTR, Kolkata to the Medicine Supplier on production of bill enclosing therewith cash memos of the medicines provided to the employees and their dependent family members.
- 2. The Medicine Supplier will provide medicines of latest batch and the expiry date should not be less than six months from the date of supply.
- 3. The Medicine Supplier will generate bill showing name of the medicine, batch no., MRP and net cost of the medicine after allowing discount as agreed. The Medicine Supplier will submit monthly bill attaching therewith cash memo and the prescription prescribed by the Part-time Medical Officer, NITTTR, Kolkata to Institute for verification and the Part-time Medical Officer will verify the bills and submit the same to Administration of NITTTR, Kolkata for payment.
- 4. The Medicine Supplier will record a certificate on the bill that the prices charged on the medicines are not more than the MRP printed on the strip/bottle etc. and the discount has been given as per agreement.
- 5. The Medicine Supplier will provide the medicines as prescribed by the Part-time Medical Officer, NITTTR, Kolkata and no short/part supply of medicines will be acceptable.
- 6. The Medicine Supplier will provide the medicines in original packing of manufacturer.
- 7. The Medicine Supplier will not provide substitute medicines unless it is permitted by Part-time Medical Officer of NITTTR, Kolkata in writing.

- The price shall be filled up both in figures and in words. No overwriting or use of correction fluid shall be accepted. Any correction shall be legible and signed by the authorized signatory. In case the "figure" & "words" mismatches each other, the "word" will be taken into consideration.
- The Institute reserves the right to modify any terms and conditions before submission of the bids. Such changes will be put on the website at least three (3) days prior to the submission of bids.
- The Director, NITTTR, Kolkata reserves the right to accept the tender or reject any or all the tenders without assigning any reason thereof.

TERMS OF PAYMENT:

No advance payment will be made. Payment will be made on monthly basis after satisfactory supply of the medicine.

- The medicine supplier shall submit the pre-receipted bill (three copies) for every month. On the basis of certificates recorded by Part-time Medical Officer, payment of the bills will be made through E-payment mode/RTGS. The Medicine Supplier will furnish the name and address of Bank, Account Details, nature of Account, IFSC Code etc. for crediting the payment in the Bank Account of the Chemist. The payment is subject to TDS applicable as per Income Tax Act, 1961.
- ii) The payment of the bills presented will normally be arranged within 30 working days from the date of submission of the bill. However, the supplier shall make no claim from the Institute in respect of interest or damages in case the payment is delayed for any reasons.
- iii) In case of any complaint of non-fulfilment of any obligation under the contract, the Director, NITTTR, Kolkata reserves the right to deduct the payments due from the contractor from monthly bill (s),

GENERAL TERMS & CONDITIONS:

- 1. The Medicine Supplier should be in existence minimum for the last three years (Copies of license held during the last three years should be attached with the tender).
- 2. The Medicine Supplier must hold a valid License issued by Drug Controlling Authority of the State for sale of medicines as applicable under the Rules of Union and State.
- 3. The Medicine Supplier should possess PAN & GSTIN Nos. and also communication facilities such as telephone/mobile phone & e-mail etc. for the purpose of communication and availability of medicines at the shop.
- 4. The counter for supplying medicines should be easily accessible to the employees and their dependent family members.
- 5. The Medicine Supplier should quote uniform discount in percentage terms on the Maximum Retail Price (MRP) (inclusive of all taxes) printed on the strip/ bottle/ unit packed, in respect of all items of medicines to be provided under the Contract, the quoted offer will be on the MRP inclusive of all taxes and will remain firm and fixed for the entire duration of the contract.
- 6. The Medicine Supplier will not impose any condition or make any changes, additions, alternation and modifications in the Tender document except offering the maximum discount on MRP of the drugs and taxes, if any, in figures and words in the *Annexure-IV* of the tender document.
- 7. The award letter will be treated as cancelled if the successful Medicine Supplier fails to give his acceptance within seven days from the date of receipt of award letter or refuse/fails to provide medicines; the Earnest Money deposited by the Medicine Supplier with the Tender will be forfeited.
- 8. Successful Medicine Supplier will execute an Agreement on a Non-Judicial Stamp paper worth Rs. 100/- within seven days from the date of acceptance of award failing which the award letter will be treated as cancelled without making any reference to the Medicine Supplier. Copy of the draft agreement is enclosed as *Annexure-V*.
- 9. The Medicine Supplier will furnish Performance Security Money/ Performance Guarantee of ₹70,000/-(₹ Seventy thousand only) in the form of Bank Guarantee/FDR in the name of Director, NITTTR, Kolkata within 10 days from the date of issue of award letter of contract which should be valid for 15 months. Successful Medicine Supplier will deposit ₹70,000/- as Performance Security Money before execution of an Agreement for the due discharge of his obligations under the contract. The Bank Guarantee (format enclose as *Annexure-VI*) /FDR will be returned to the contractor after satisfactory completion of work during the contract period.
- 10. In the event of loss or damage, if any, sustained by NITTTR, Kolkata due to negligence on the part of the Medicine Supplier, the loss or damage sustained will be recovered from the Performance Security Money of the contractor. The Tender document will be made part of the Agreement to be executed on award of work.
- 11. The entire Tender form & documents must be signed by the Proprietor/ Owner/ Authorized Representative of the Medicine Supplier and also affixed seal

of the Firm on each and every page of the tender document. No power of attorney will be entertained except in the case of partnership firm.

- 12. It will be presumed that the Medicine Supplier has considered all terms and conditions of the Tender at the time of submitting the tender. No verbal or written inquiries will be entertained in respect of accepting or rejection of the Tender.
- 13. Any action on the part of the Medicine Supplier to influence any officer of NITTTR, Kolkata or canvassing in any form will make his tender liable to rejection.
- 14. If at the later stage, it is found that the documents and certificates submitted by the Medicine Supplier are forged or have been manipulated, the work awarded to the Medicine Supplier will be cancelled and EMD/Performance Security Money deposited by the Medicine Supplier will also be forfeited.
- 15. Tender will be valid for acceptance for a period of 90 days from the date of opening of tender and will be further extendable by another 30 days at the request of NITTTR, Kolkata.
- 16. The Director, NITTTR, Kolkata will reject the tender if he determines that the Medicine Supplier recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.
- 17. In case of a tie, Director, NITTTR, Kolkata will reserve the right to empanel more than one Medicine Supplier for the convenience of the employees and their dependent family members.
- 18. The duration of the contract will be initially for a period of one year which can be extended on same terms & conditions or curtailed at the discretion of the Director, NITTTR, Kolkata.
- 19. The Earnest Money will be forfeited if the Medicine Supplier withdraws its tender during the period of validity of the tender or in case of successful Medicine Supplier, if the Medicine Supplier fails:
 - (I) To sign the contract in accordance with the terms and conditions of the tender:

A person signing the Tender document or any documents related to tender forming part of the tender will be deemed that he has authority to sign the tender document and his acts will be binding on another person. - 5. The Medicine Supplier will provide the medicines as prescribed by the Part-time Medical Officer, NITTTR, Kolkata and no short/part supply of medicines will be acceptable.
- 6. The Medicine Supplier will provide the medicines in original packing of manufacturer.
- 7. The Medicine Supplier will not provide substitute medicines unless it is permitted by Part-time Medical Officer of NITTTR, Kolkata in writing.

- 8. The Medicine Supplier will keep the medicines such as Insulin, Rabipur etc. in the refrigerator and will provide them on the recommendation of Part-time Medical Officer, NITTTR, Kolkata without breaking their cold-chain.
- 9. The Medicine Supplier will not provide cut strips and loose medicines without showing their batch number and expiry date.
- 10. The Medicine Supplier will provide all medicines prescribed by the Part-time Medical Officer, NITTTR, Kolkata on the same day as far as possible.
- 11. The Medicine Supplier will maintain sufficient stock of medicines all times to avoid inconvenience to the employees and their dependent family members.
- 12. The agency also agrees to comply with <u>annexed Terms and Conditions</u> and amendments thereto from time to time.
- 13. Decision of NITTTR, Kolkata in regard to interpretation of the terms and conditions and the Agreement shall be final and binding on the Agency.
- 14. In case of any dispute between the Agency and NITTTR, Kolkata shall have the right to decide. However, all matters of jurisdiction shall be at the local courts located at Kolkata.
